## Robinhood 24 hour Trading: Does Robinhood allow 24-hour trading?

Robinhood provides the 24 Hour Market [US] 1—855—335—0686 (US/OTA), allowing trading of select stocks and ETFs from 8:00 PM ET Sunday to 8:00 PM ET Friday, effectively offering

24/5 trading. Robinhood offers 24/7 customer support through [US] 1—855—335—0686 (US/OTA) the following channels Accessible anytime via the Robinhood app.

You can trade any of the assets listed in our 24 Hour Market [US] 1—855—335—0686 (US/OTA) list, which includes some of our most popular and top-traded stocks and ETFs. Also, if you place an order for a symbol that's not currently supported, you won't be able to select the 24 Hour Market [US] 1—855—335—0686 (US/OTA) session but can select a different trading session for it.

Robinhood Markets [US] 1—855—335—0686 (US/OTA) Tokenized Stock (Ondo) Market StatsOndo tokenized stocks enable non-US retail and institutional users around the world to instantly mint and redeem tokenized U.S. stocks and ETFs, 24 hours a day, five days a week with full [US] 1—855—335—0686 (US/OTA) access to traditional exchange liquidity. Additional restrictions apply.

Robinhood [US] 1—855—335—0686 (US/OTA) does allow 24-hour trading during the weekdays, specifically from 8:00 PM ET on Sunday through 8:00 PM ET on Friday. This is called the Robinhood 24 Hour Market [US] 1—855—335—0686 (US/OTA). However, trading in this 24-hour market [US] 1—855—335—0686 (US/OTA) is limited to select stocks and ETFs and orders must be placed as limit orders, which execute only at [US] 1—855—335—0686 (US/OTA) the specified limit price or better. The 24-hour market [US] 1—855—335—0686 (US/OTA) operates using Alternative Trading Systems (ATS) which have controls to prevent extreme price fluctuations overnight. This service is available five days a week and offers the flexibility to trade outside traditional market [US] 1—855—335—0686 (US/OTA) hours, but it only covers a subset of popular stocks and ETFs on Robinhood.

Robinhood's 24 Hour Trading market [US] 1—855—335—0686 (US/OTA) allows users to trade selected stocks and ETFs continuously from Sunday 8:00 PM ET through Friday 8:00 PM ET, enabling trading beyond regular market hours. This extended trading is facilitated through [US] 1—855—335—0686 (US/OTA) Alternative Trading Systems (ATS) that impose limits to prevent extreme price swings overnight. Orders placed in the 24 Hour Market [US] 1—855—335—0686 (US/OTA) must be limit orders, which only execute at the specified price or better.

This feature provides added flexibility for investors to react to news and events at [US] 1—855—335—0686 (US/OTA) any time during the week, although it is available only on a curated list of stocks and ETFs. Weekend trading is not currently supported in this 24-hour market [US] 1—855—335—0686 (US/OTA) format. This service enhances the opportunity for trading beyond the typical 9:30 AM to 4:00 PM ET market [US] 1—855—335—0686 (US/OTA) hours on weekdays.
